Apply Gallery SC at or above the 23 oz. rate, matching equivalent treated acres of Dimension Ultra 40WP or Dimension 2EW at 0.5 lbs a.i. per acre to receive additional rebate on Gallery SC. - 1. Qualifying products must be invoiced during the defined purchase period of October 1, 2018 September 30, 2019.
- 2. You must submit your Rebate Form online. You can upload your invoices, if required, or mail them along with a copy of your completed submission to the address below. **Invoices can be uploaded or mailed with a postmark date of no later than October 31, 2019:**

Please note that future purchase acknowledgements or internal purchase summary reports will not be accepted.
- 4. Corteva Agriscience™, Agricluture Division of DowDupont, Program Administration will be responsible for completing final calculations. All decisions will be final.
