#### 4. First-Aid Measures

## **Description of first aid measures**

#### General advice:

First aid providers should wear personal protective equipment to prevent exposure. Remove contaminated clothing. Move person to fresh air. #### Methods and material for containment and cleaning up

Dike spillage. Pick up with suitable absorbent material. Place into suitable containers for reuse or disposal in a licensed facility. If application of spilled substance/product is not possible, then spills should be contained, solidified, and placed in suitable containers for disposal. ## 7. Handling and Storage

## Precautions for safe handling
