**ONGUARD PNP PRO RESIDUAL** kills insects as listed below. In addition to contact kill, this residual spray stays on treated surfaces and kills insects after the spray deposit has dried. This insect spray is ready to use undiluted. **Kills Spiders, Sowbugs, Earwigs, Cockroaches, Crickets, Silverfish, Firebrats, Ants, Fleas, Carpet Beetles, Brown Dog Ticks, Cluster Flies, House Flies, Bees, Wasps, Yellow jackets, and Hornets on Contact**

**DIRECTIONS FOR USE:**

For use in and around: apartments, homes, transport vehicles, cattle quarters, milk rooms, dairy barns, horse barns, food processing plants, restaurants, hotels, and hospitals. Thorough applications may be applied onto surfaces or into cracks and crevices for insect control. If re-infestations occur, repeat applications as necessary. Provide adequate ventilation after indoor use. **KEEP PETS AND CHILDREN AWAY FROM SURFACE UNTIL DRY.**

**TO CONTROL SPIDERS, SOWBUGS, EARWIGS, COCKROACHES, CRICKETS, SILVERFISH, FIREBRATS, ANTS, FLEAS, CARPET BEETLES, BROWN DOG TICKS, CLUSTER FLIES AND HOUSE FLIES:**

**INDOOR USE:** Use of a suitable professional pressurized sprayer capable of spot or crack & crevice treatments is required. Apply **ONLY** as a coarse spray to infested surfaces until wet, moving the spray stream rapidly enough to prevent excessive wetting of surfaces and waste of material. Thoroughly treat cracks and crevices and spots along baseboards, underneath furniture and equipment, around garbage containers, localized areas of floors and floor coverings and other places where insects harbour. For ants, spray trails and places where ants enter premises such as window and door sills.

**CAUTION:** In meat packaging and food processing plants, only spray when plant is not in operation. No exposed food products, ingredients, or packaging materials to be left in the room. Cover all food processing surfaces and food handling equipment. Any treated surfaces that may contact meat food products or other food products should be washed and rinsed thoroughly with potable water after spraying and before re-use for food processing. In homes or dwellings, remove or cover all exposed foods and cooking utensils before spraying.

**OUTDOOR USE:** Spot Treatment: Use of a professional pressurized sprayer capable of spot treatments is required. Apply as a coarse spray to outside surfaces of screens, doors, window frames, foundations, patios, light fixtures and other places where insects may alight, or congregate and enter. For ants, spray hills and runways. The cluster flies and house flies will be killed when they land on the treated surfaces.

**TO CONTROL BEES, WASPS, YELLOW JACKETS AND HORNETS:**

**OUTDOOR USE:** Use of a professional pressurized sprayer capable of jet sprays is required. Apply as a jet spray to completely saturate the nests of **Bees, Wasps, Yellow jackets, and Hornets**, from a distance of 2 to 2.5 metres. Allow sufficient time for insects to die. Application to nests should be made in late evening or early morning when insects are at rest.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. May be harmful if swallowed, inhaled or absorbed through skin. Provide adequate ventilation of area being treated. Avoid contact with

skin, eyes and clothing. Avoid breathing spray mist. Wear a mask or respirator and protective clothing while applying. Do not remain in treated areas. Wash thoroughly with soap and warm water after using. Do not use on humans, plants or animals. Do not use as a space spray. Cover fish bowls and remove pets for one hour when spraying. Do not use in areas where food is handled, prepared or stored. Remove or cover all exposed foods or cooking utensils before spraying. Do not allow children or pets to contact treated areas until surfaces are thoroughly dry. Do not contaminate food, utensils or animal feeding areas. Toxic to bees, fish and wildlife. Do not contaminate any body of water, either by direct application or by cleaning of equipment or disposal of wastes. Do not spray near open flame or spark, or while smoking. Do not spray asphalt shingles, as this product may stain them.

**FIRST AID:** If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take container, label or product name and PCP Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Contains petroleum distillate. Vomiting may cause aspiration pneumonia. Treat symptomatically.

**DISPOSAL:** Do not reuse this container for any purpose. This is a recyclable container, and is to be disposed of at a container collection site. Contact your local distributor/dealer or municipality for the location of the nearest collection site. Before taking the container to the collection site: 1. Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the sprayer. 2. Make the empty, rinsed container unsuitable for further use. If there is no container collection site in your area, dispose of the container in accordance with provincial requirements.

For information on the disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.

**STORAGE:** Store in a cool dry area away from heat.
