Formulated with patented technology, the product is made to provide triple-action mosquito control including fast kill on contact, lasting larvae control in standing water and extended spatial repellency with lowest possible impact on user and the environments.

The product can also be used indoors or outdoors to control aphids, ants, fleas, lice, mites and ticks. May be used for in and around structure of environments including but not limited to: residential, commercial, municipal, schools, dormitories, hotels, health care, public transportation and other locations where infestations may occur.

**DIRECTION FOR USE:** Read the entire label and **SHAKE WELL BEFORE MIXING AND USE.**

**MIXING INSTRUCTIONS AND EQUIPMENT:**

This product should be mixed only with water as instructed. Use equipment such as compressed air sprayers, backpack sprayer, ULV fogger or any non-thermal conventional fogging/spraying/misting equipment. Clean sprayer before use. Shake product well before mixing. Add about half of required amount of water to the tank first and then add the required amount of product, then add the remaining water. Seal tank and agitate well before use. Apply directly on surface to the point of run off. Suggest using mixed solution within 24 hours and maintain light agitation during use. Rinse equipment tank, hose and nozzle with water after use.

**PRECAUTIONARY STATEMENT:**

Avoid direct contact with eyes and mouth. May be harmful if swallowed. May cause eye irritation or skin rash on sensitive skin type. Wash hands after use. Do not use if allergic to the product. Product contains aromatic botanical extracts. Scent may be objectionable under prolonged exposure and it can be quickly dissipated with ventilation. For use in non-food areas only of food handling establishments. Do not spray directly on fruit, edible crops or feed use sites. PPE such as goggles and gloves are required when applied by fogging and used indoors in California.

**FIRST AID**

If product gets in eyes, hold eye open and flush with clean water gently for at least 15 minutes. If irritation persists, contact a physician. If product gets on skin, wash exposed area thoroughly with soap and water. If inhaled, move exposed person(s) to fresh air. If breathing problems persist, get medical attention. If ingested, rinse mouth out with water. If feeling sick, call a poison control center or doctor immediately. In case of spill or leakage, soak up with any absorbent material and dispose in trash.

**STORAGE & DISPOSAL**

Store upright in original container and keep tightly closed when not in use. Avoid heat or direct sunlight. Do not reuse container. Recycle or discard.

**MIXING AND APPLICATION RATE**

Target Insects	Application	Mixing Ratio with Water (EcoVenger : Water)	Remarks
Mosquitoes and Larvae	Municipal, commercial and residential surface and areal spray and direct treatment of stagnant water sources as adulticide, larvicide and repellent. Repeat in 2 or 3 weeks if necessary.	For mild activity: Mix 1 part of ER-3 with 30 parts of water. For heavy activity: Mix 1 part of ER-3 with 15 parts of water. For direct application to water sources mix 1 parts of ER-3 with 15 part of water.	For general spray on structure or vegetation. Residual duration depends on the weather condition such as wind, rain and temperature. May also be used as a direct application to stagnant water.
Aphids and Mites	General treatment with plants involved, for both indoors and outdoors. Repeat in 2-3 weeks if necessary.	Mix 1 part of ER-3 with 20 parts water.	For general spray on vegetation. For edible crops, advise customer to rinse thoroughly before serving.
Fleas, lice and ticks	General treatment for both indoors and outdoors. Repeat when necessary.	With plants involved: Mix 1 part of ER-3 with 20 parts water. With no plants involved: Mix 1 part of ER-3 with 5 parts water.	For general spray indoors or outdoors on furniture, structure, and on birds or animals.
