For skin effects, a highly efficient therapeutic agent for Pyrethroid exposure is topical application of Tocopherol Acetate (Vitamin E).

5. FIRE FIGHTING MEASURES

Marginally higher incidences of benign liver tumors in mice were observed following lifetime high dose exposures to PBO. The significance of these observations is questionable and under review. The doses at which tumors were observed for PBO greatly exceeded potential human exposure from labeled uses. Doses at which these effects were observed greatly exceeded anticipated human dietary intake.
