PRECAUTIONS: KEEP AWAY FROM CHILDREN, PETS AND LIVESTOCK. Bait station contents may be harmful or fatal if swallowed or absorbed through the skin. Rubber gloves must be worn when collecting and disposing of emptied bait stations and disposing of dead rodents. Avoid contact with eyes, skin or clothing. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Wash skin thoroughly with soap and water after handling. Wash contaminated clothing, separately from other laundry, with soap and water before reuse. **KEEP AWAY FROM FEED AND FOODSTUFFS.**

FIRST AID: If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. For all cases of human ingestion, immediately notify a physician or Poison Control Centre. If

a pet or livestock poisoning is suspected, immediately contact a veterinarian. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Vitamin K₁ in the form of intramuscular or subcutaneous injections, or by oral ingestion are suggested remedial treatments for anticoagulant poisoning. The severity of the case measured by establishing prolonged prothrombin times (P.T.) will determine appropriate therapy. Monitoring P.T. will indicate the necessity of repeated treatments.

ENVIRONMENTAL HAZARDS: This product is toxic to fish and wildlife. Keep out of lakes, streams or ponds.

DIRECTIONS FOR USE

Use bait to control the Norway rat (*Rattus norvegicus*) and Roof rat (*Rattus rattus*) indoors and outdoors within 15 metres of buildings.

USE LIMITATIONS: This bait station may be used indoors and outdoors within 15 metres of buildings accessible to children, pets and non-target animals, consistent with all use restrictions and other requirements indicated on this label. **DO NOT** place bait in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food.

SELECTION OF TREATMENT AREAS: Determine areas where rats will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been observed. Maintain a steady supply of fresh bait. Remove any spoiled or contaminated bait promptly.

APPLICATION DIRECTIONS

Use 1 to 4 stations for rats, every 5 to 10 metres . Place bait stations at highest point of activity beside burrows, along a wall or in corners where rats or their signs have been seen. Maintain an uninterrupted supply of fresh bait for 10 days , or until signs of rat activity cease in infested areas. Replace bait stations if contents are consumed or contaminated.

Collect and dispose of unconsumed bait and dead exposed animals according to local requirements. To prevent reinfestation, eliminate food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish bait as needed.

DISPOSAL: Do not reuse empty container. Wrap unwanted or damaged bait stations and discard in household garbage. **DO NOT** use damaged bait stations.

RODENT DISPOSAL: Dispose of dead rodents in garbage or by burying.

STORAGE: Store in cool, dry place away from other chemicals and food or feed. Store product not in use, in original container, in a secure location inaccessible to children and non-target animals.
