Turf Pro can be used as a soil inolculant, foliar spray, in hydroponics and for compost teas. Turf Pro may aid in micro nutrient uptake and increase water retention. This product provides soil biology, humic acid, as it is derived from a concentrated liquid ancient humus compost. Turf Pro is non-toxic & safe to use around people when used as directed

#### RECOMMENDED RATES

Turf Application: Commercial Spray Application - add concentrate at a dilution rate of 4% product to 96% water in sprayer holding tank.

Hose-end Sprayer Application: Apply at a rate of 2 ozs. Per gallon of water

Coverage: Apply at a concentrated rate of 6 ozs. Per 1000 square feet. For stressed or damaged turf, apply at a rate of 12 ozs. Per 1000 square feet For golf course fairways, sod farms and hav farms, apply at a rate of onegallon per acre. Treat in early spring, summer and fall

Crop Application: Apply at a rate of one-gallon of concentrate diluted in water to cover one acre.

Plants and Shrubs Application: For large developed plants and shrubs, apply as a root drenched with a diluted rate of 4 ozs. Per gallon of water. For smaller, fragile plants, use a dilution rate of 2 ozs. Per gallon of water. Repeat application every two to four weeks except when temperatures falls below 50F.

SHAKE WELL OR MIX BEFORE USING. USE ON: Citrus, Vegetables, Trees, Shrubs, Flowers, Crops, and Turf + Indoor & Outdoor Containers and soil
