ONGUARD PNP LIQUID RESIDUAL kills insects as listed below. In addition to contact kill, this Residual Spray stays on treated surfaces and kills insects after the spray deposit has dried. This insect Spray is ready to use undiluted, and is applied using the attached application device to ensure target applications. Controls Spiders, Sowbugs, Earwigs, Cockroaches, Crickets, Silverfish, Ants, Fleas, Carpet Beetles, Brown Dog ticks, Cluster Flies, House Flies, Bees, Wasps, Yellow jackets, and Hornets

**DIRECTIONS FOR USE:** DO NOT apply as a space spray or broadcast application. ONLY spot or crack and crevice applications are permitted indoors in residential areas. Spot application is localized to a surface area not more than 0.2 m2. Spots are not to be adjoining. The combined area of spots is not to exceed 10% of the total surface area of a room. Crack and crevice is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

DO NOT apply to any body of water. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. Avoid application of this product when winds are gusty.

• DO NOT apply to furniture, mattresses, linens, toys or clothing. For all applications (EXCEPT when used outdoors to control bees and wasps (including hornets and yellow jackets) in their nests): DO NOT apply to overhead areas or in confined spaces (for example, attics, crawlspaces, eaves, soffits). Ventilate treated areas after application by opening windows and doors or using fans where required to aid in the circulation of air. DO NOT apply when people or pets are present. DO NOT allow people or pets to enter treated areas until sprays have dried. DO NOT allow spray to drip or allow drift onto non-target surfaces. DO NOT apply to any body of water. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. Avoid application of this product when winds are gusty. DO NOT contaminate food/feed. DO NOT apply to surfaces that may come into contact with food/feed. Cover or remove all food/feed. Cover all food/feed processing surfaces, equipment and utensils or thoroughly wash following treatment. DO NOT apply in areas where plants are grown for food or feed (e.g., vegetables, fruit, herbs). DO NOT apply to people, pets, livestock or sources of electricity.

Hold container approximately 30 cm from the surface being sprayed and spray until wet. This ready-to-use liquid should be applied with the available trigger spray nozzle that attaches to the bottle. Thorough applications may be applied onto surfaces or into cracks and crevices for insect control. LIMITATIONS: Do not use as a stream spray inside homes.

## **INDOOR USES**

TO CONTROL SPIDERS, SOWBUGS, EARWIGS, COCKROACHES, CRICKETS, SILVERFISH, ANTS, FLEAS, CARPET BEETLES, BROWN DOG TICKS: Apply ONLY as a coarse spray to infested surfaces until wet, moving the spray rapidly enough to prevent excessive wetting of surfaces

and waste of material. Thoroughly treat cracks and crevices and spots along baseboards, underneath furniture and equipment, around garbage containers, localized areas of floors. For ants, spray trails and places where ants enter premises such as window and door sills. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

## OUTDOOR USE ON THE EXTERIOR SURFACES OF BUILDINGS AND PORCHES, PATIOS AND DECKS:

TO CONTROL SPIDERS, SOWBUGS, EARWIGS, COCKROACHES, CRICKETS, ANTS, FLEAS, BROWN DOG TICKS, HOUSE FLIES AND CLUSTER FLIES. Spot Treatment: Apply as a coarse spray to the outside surfaces of foundations, under eaves, around light fixtures, and places where listed pests enter (e.g., screens, doors, window frames). For ants, spray hills and runways. The cluster flies and house flies will be killed when they land on the treated surfaces. Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

**OUTDOOR USE TO CONTROL BEES AND WASPS (INCLUDING HORNETS AND YELLOW JACKETS) IN THEIR NEST:** Apply as a stream spray to completely saturate the nests of **Bees, Wasps, Yellow jackets, and Hornets,** from a distance of 2 to 2.5 metres. Allow sufficient time for insects to die. Application to nests should be made in late evening or early morning when insects are at rest. Treatment must only be repeated if pest problem persists or reoccurs.

**PRECAUTIONS**: KEEP OUT OF REACH OF CHILDREN. May be harmful if swallowed, inhaled or absorbed through skin. Provide adequate ventilation of area being treated. Avoid contact with skin, eyes and clothing. Avoid breathing spray mist. Wash thoroughly with soap and warm water after using. Cover fish bowls for one hour when spraying. Do not spray near open flame or spark, or while smoking. Do not spray asphalt shingles, as this product may stain them.

**ENVIRONMENTAL PRECAUTIONS:** Toxic to aquatic organisms. Toxic to birds and wildlife. Toxic to bees. Toxic to beneficial insects.

FIRST AID: If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take container, label or product name and PCP Registration Number with you when seeking medical

attention.

**TOXICOLOGICAL INFORMATION**: Contains petroleum distillate. Vomiting may cause aspiration pneumonia. Treat symptomatically.

**DISPOSAL:** Do not reuse empty container. Wrap container in several layers of newspaper and discard in garbage.

**STORAGE:** Store in a cool dry area away from heat.
