DIRECTIONS FOR USE

Recommended application modes: foliar spray, fertigation injection, or drip irrigation.

TURF APPLICATION RATE

Apply GETGREEN® at 5 pounds (5 scoops) to 10 pounds (10 scoops) per acre bi-weekly. Increase/decrease rate according to frequency of application. Apply only to actively growing turf.

DECORATIVE PLANTS RATE

Apply GETGREEN® at 1 ounce to 2 ounces per 1000 square feet for color, growth or remedial action on plant.
