EASY APPLICATION INSTRUCTIONS

APPLY USING A ROTARY SPREADER - RECOMMENDED SPREADER SETTING IS 60%.

INITIAL APPLICATION: Sprinkle to form a border approximately 15 to 18 inches out from the bed, tree or bushes with a 20-24 inch band of Iguana Scram. Apply so it is visibly heavy enough to see. Sprinkle around tree bases to keep iguana's from climbing tree to get to any vegetation.

FOR EXCESSIVE PROBLEMS IN HIGH IGUANA DENSITY AREAS: Apply as above **AND ADD** a second band **15 INCHES OUT FROM THE FIRST STRIP** around the bed, trees or bushes, and broadcast Iguana Scram lightly throughout the inside of the bed. This will stop the problem and only a single band nearest the bed will be needed thereafter for maintenance applications going forward.

REAPPLY May have to reapply after heavy rainfalls.

ALL SEASON USE Can be used in any climate or temperature.

DO NOT USE on food or feed crops. Do not apply directly to water.
